FOR THE ABOVE: THE SUBSCRIBER HEREBY WAIVES, RELEASES AND HOLDS HARMLESS THE CITY OF BROOKLYN, BROOKLYN SENIOR SERVICES AND THE BROOKLYN POLICE DEPARTMENT AND EMPLOYEES AND / OR VOLUNTEERS OF THESE ENTITIES FROM ANY CLAIM ARISING FROM A FAILURE, FOR ANY REASON, TO PROVIDE THE SERVICES CONTEMPLATED BY THIS AGREEMENT. THE SUBSCRIBER FURTHER AGREES TO WAIVE, RELEASE AND HOLD HARMLESS THE CITY OF BROOKLYN, BROOKLYN SENIOR SERVICES AND THE BROOKLYN POLICE DEPARTMENT AND ANY EMPLOYEES AND / OR VOLUNTEERS OF THESE ENTITIES AGAINST ANY CLAIM FOR DIRECT, INCIDENTAL OR CONSEQUENTIAL DAMAGES ARISING FROM ANY ACT (INCLUDING BY NOT LIMITED TO) DAMAGE CAUSED TO SUBSCRIBERS PROPERTY PURSUANT TO THE R.U.O.K. PROGRAM OR OMISSION OF THE CITY OF BROOKLYN, BROOKLYN SENIOR SERVICES AND THE BROOKLYN POLICE DEPARTMENT, THEIR VOLUNTEERS, AGENCIES OR EMPLOYEES, IN CONNECTION WITH THE CITY OF BROOKLYN’S, BROOKLYN SENIOR SERVICES AND THE BROOKLYN POLICE DEPARTMENT’S PARTICIPATION IN THIS PROGRAM.
