

**MINUTES OF THE REGULAR MEETING OF THE
CITY OF BROOKLYN CIVIL SERVICE COMMISSION
WEDNESDAY, FEBRUARY 21, 2018 5:00**

Meeting called to order at 5:00 p.m.

MEMBERS PRESENT: Chairman Joe Magrey and Commissioner Larry Hull.

MEMBERS ABSENT: Commissioner Michelle Rivera.

MOTION by Chairman Magrey, second by Commissioner Hull to approve the minutes of the regular meeting held Wednesday, January 24, 2018.

VOTE RESULTED: Yeas – Magrey and Hull. Nays – None.

MOTION by Chairman Magrey, second by Commissioner Hull to approve the minutes of the special meeting held Wednesday, February 7, 2018.

VOTE RESULTED: Yeas – Magrey and Hull. Nays – None.

Discussion regarding part-time positions at the Recreation Center followed. After discussion, **MOTION** by Chairman Magrey, second by Commissioner Hull to waive Rule XII, Section 4 (b) requiring the publishing of notice of examination in (2) consecutive issues of a newspaper of general circulation and notification to the Clerk of the Common Pleas Court of Cuyahoga County, Ohio for the 2018 hiring of part-time recreation center lifeguards, water safety instructors (WSI), baseball workers, part-time maintenance, pool attendants, sport court attendants, day camp counselors, soccer workers, and cashiers. The Commission further grants permission to the appointing authority to develop the public notice for said positions and to hire these positions through the process of a structured interview.

VOTE RESULTED: Yes – Magrey and Hull. Nays – None.

Discussion regarding the firefighter/paramedic exam followed. After discussion, **MOTION** by Chairman Magrey, second by Commissioner Hull to create new supplemental list for the entry level firefighter/paramedic test. We will not revoke the existing list from the test taken on October 28, 2015. All candidates from that exam with a passing score will receive a letter instructing them to have the option to either retain their current score or take the test to be scheduled for Thursday, March 22, 2018 at no cost and must return a reply by 4:00 pm, Friday, March 16, 2018. Those candidates from that exam remaining on the list will be intermingled and a new list will be created containing all eligible candidates.

VOTE RESULTED: Yes – Magrey and Hull. Nays – None.

MOTION by Chairman Magrey, second by Commissioner Hull to waive Rule XII, Section 4 (b) requiring the publishing of notice of examination in (2) consecutive issues of a newspaper of general circulation and notification to the Clerk of the Common Pleas Court of Cuyahoga County, Ohio. The ad will appear on Cleveland.com and the City of Brooklyn website from February 26, 2018 through March 16, 2018. Additional posting may be sent to other organizations promoting firefighter/paramedic training.

The Commission also review the firefighter/paramedic application and documents that the candidates will receive.

There being no other business to come before the Commission, **MOTION** by Chairman Magrey, second by Commissioner Hull to adjourn.
