

**MINUTES OF THE SPECIAL MEETING OF THE
CITY OF BROOKLYN CIVIL SERVICE COMMISSION

MOTION by Commissioner Patta, second by Chairperson Magrey to approve minutes from regular meeting held February 19, 2020.
