IMPROVEMENT PLANS
IN THE CITY OF BROOKLYN, OHIO 44144

PUBLIC NOTICE 9/17/13

On Friday, September 20th, 2013, at 5:30 AM weather permitting, Perk Company, Inc. will modify the current traffic zone **for one day** on the above named project for Cuyahoga County. The zone will consist of reducing traffic to one lane northbound on the East side curb lane of Ridge Road from North of West 66th St. to Memphis Ave. Southbound Ridge Rd. will be closed at Memphis Ave. Southbound traffic will be detoured to westbound Memphis Ave., then southbound on Tiedeman Rd., then eastbound on Biddulph Rd. and then return to southbound on Ridge Rd. Local southbound traffic from West 66th St. to Biddulph Rd. will be maintained in its current configuration.

This will be done to accomplish placement of the new concrete roadway and complete the pavement on the West of Ridge Rd. to the centerline of Ridge Rd. in Section 3. Message boards will be placed prior to the new zone implementation to inform the public of the forthcoming closure. Police officers with police cruisers will be on site during the detour. The traffic zone should be returned to its present configuration that evening at the conclusion of the concrete placement. Additional notices will be sent as the project progresses.
